Urinary hesitancy	<ul> <li>Assess and document symptoms; notify provider</li> <li>Monitor intake and output</li> </ul>
Sedation	<ul> <li>Assess and document sedation</li> <li>Assess and document risk for falls</li> <li>Implement fall-risk protocol</li> <li>Communicate with provider about timing of medications</li> <li>Educate client not to operate heavy machinery while taking sedating medications</li> </ul>
Orthostatic hypotension	<ul> <li>Assess and document blood pressure</li> <li>Communicate with provider assessment details</li> <li>Educate client about rising slowly, sitting before standing, using handrails</li> </ul>
Amenorrhea/gynecomastia	<ul> <li>Assess and document findings; notify provider</li> <li>Educate client about mechanism of side effects</li> <li>Discuss with provider and client about possibility of alternate medication/decrease in medications</li> </ul>
Metabolic side effects (Metabolic syndrome)	Assess weight and BMI before and during regular intervals while taking medication

Agranulocytosis	<ul> <li>Assess and document white blood cell count and absolute neutrophil count at initiation of treatment and during treatment (according to REMS protocol with Clozaril clients)</li> <li>Communicate findings with provider</li> </ul>
